



The first stage of the DUT Call 2024 closed on 14 November 2024 13.00 CET.
More than 2200 project partners applied for approx. 275 M Euro in funding in 254 proposals.
110 proposals were invited to the second stage, which closed on 24 April 2025 13.00 CEST.
47 proposals were suggested for funding.
