


Venue Map



Workshop: Developing DUT Valorisation Strategy

The DUT Partnership is seeking to support urban actors by mobilising transnational R&I funding for projects that create value beyond the usual financial business cases. An important rationale is to prepare cities and urban areas for the economic change that will be needed for our societal transformation towards climate neutrality.

Value, in this new context, will be appreciated in ways that are quite different from today, and business value might turn out to be of less importance than in the past. Many cities are already establishing their own ways of assessing and appreciating the investments that they are planning, to keep their local economy prosperous and their citizens safe in the future.

The workshop will highlight the valorisation approach that is being developed by DUT, discuss its different dimensions of value, and invite participants to contribute and share from their own experience.

Roundtable Exercise on Mission-Led Urban Transformation

To meet the challenges of the 21st century, our urban communities need to make rapid, far-reaching and unprecedented changes. Otherwise, we face compounding social and ecological crises. Although this has been clear for some time, communities in most places are still only managing slow, incremental and fragmented change that is insufficient to address the challenges of our time.

A mission-led approach pushes us to explicitly reframe, rethink and reorganise around what is actually needed rather than what we currently think is possible. This demands a massive shift in our mindsets. It means working very differently to how most of us have been trained and rewarded to operate. It will require substantial organisational reshaping.

During this participatory roundtable exercise, we will test our current capacities for mission-led change work, and explore some key ingredients of a mission-led approach to change for our communities.

8 Showcasing Best-Practice Examples of European Circular Urban Economy

An ongoing initiative to map best-practice cases throughout Europe is carried out by the DUT Circular Urban Economies (CUE) Transition Pathway in collaboration with Sweco. The activity is focused on a data collection process to map circular urban economy cases across European cities and towns. The activity serves to develop a framework and enable deep dives with selected cases for subsequent compilation within the CUE innovation portfolio. 9 European Community Land Trust Network

The European Community Land Trust Network is a platform for over 350 Community Land Trusts (CLTs) across Europe. The Network's goal is to grow the CLT movement by supporting the creation of new CLTs and reaching new countries.

As its European voice, they work to raise awareness of the CLT model among policymakers, non-governmental organisations, and activists in the cooperative housing sphere, and to collaborate with development partners to drive social, design, construction and environmental innovation within housing.

The CrAFt Cookbook: A Recipe for Climate-Positive Cities and Communities

The CrAFt Cookbook outlines seven stages for urban transformation inspired by the New European Bauhaus, covering everything from conceptualisation to execution, documentation, and replication. Each stage highlights key principles and joint strategies, with real-life examples from CrAFt Cities, to inspire any city's initiatives.

DUT Public Officers and Practitioners Community

The Public Officers and Practitioners Community (POP-C) enables local authorities and municipalities to translate urban transition strategies into local action. The aim of DUT is to create, support, and engage members of the POP Community through capacity building on main gaps and promote international cooperation. For this reason, the POP-C Tool was developed: a repository platform with a social dimension specifically designed for members of the POP Community

12 DUT City Panel

The DUT City Panel facilitates direct engagement with urban public authorities to advance climate-neutral, inclusive cities. Through active consultation and collaboration, we shape solutions with urban administrators, leveraging their expertise and needs. Established in 2022, the City Panel serves as a collaborative platform, offering cities two key benefits:

- Peer-to-peer learning: Cities exchange insights and strategies for achieving urban climate neutrality, sharing project experiences and tools.
- Strategic influence: Cities contribute needs to shape DUT's initiatives, ensuring alignment with urban goals.

CapaCITIES is the European growing network connecting the national support structures and platforms that work in their contexts to advance the Cities Mission implementation at national level.

Positive Energy Districts - Updating the Narrative

Positive Energy Districts (PEDs) play a crucial role in the transformation of cities towards a carbon-neutral future and the urban energy transition. However, the role of PEDs in the climate-neutral city has not been clearly defined yet and there is still ambiguity and regarding the precise framework of the PED concept. The Driving Urban Transitions (DUT) Partnership has initiated a broad stakeholder consultation process on updating the PED Framework Definition as a key building block towards climate-neutral cities - join in!

15 Urban Transitions Mission Centre

The Urban Transitions Mission Centre (UTMC) is a global platform that promotes urban sustainability and facilitates climate-neutral transitions in cities worldwide. Their mission is to bridge the gap between local action plans and the pace of current transformations by providing evidence-based solutions, good practices, and advanced frameworks. Funded by the European Union's Horizon Europe, the UTMC collaborates with a consortium of urban experts from organizations such as the Austrian Research Promotion Agency, the European Network of Living Labs, Eurocities, the Global Covenant of Mayors for Climate and Energy, ICLEI – Local Governments for Sustainability, and LGI Sustainable Innovation
